**SECTION II STANDARD TERMS AND CONDITIONS FOR CONSORTIA**
**1 DEFINITIONS**

1.1 In this Agreement the following words shall have the following meanings:

- 1.1.1 **Authorised User:** (i) any current student, member of faculty, staff and researchers of Licensee who is authorised by a Licensee to access the Secure Network; and/or (ii) any individual granted temporary permission by a Licensee to access the Secure Network whilst on its premises (Walk-in-User); (iii) outsourced faculty and/or staff previously employed by the Licensee in their performance of services for and on behalf of the Licensee only; (iv) retired faculty, staff and researchers of the Licensee; . Walk-In Users may not be given means to access the Purchased Product and Journals Shallow Archive when they are not within the physical premises of the Licensee. For the avoidance of doubt, Walk-In Users may not be given access to the Purchased Product and Journals Shallow Archive by any wireless network provided by the Licensee unless such a network is a Secure Network.
- 1.1.2 **Educational Purposes:** for the purpose of education, teaching, distance learning, private study, retrieving information and/or research.
- 1.1.3 **Commercial Use:** for the purposes of direct or indirect financial gain (whether by or for Licensee, an Authorised User, or any other person or entity) by means of sale, resale, loan, transfer, hire or other form of exploitation of the Products. For the avoidance of doubt, neither recovery of direct costs required by law by the Licensee from Authorized or Walk-in-Users or from the receiving library in the case of Inter Library Loan, use by the Licensee, Authorized or Walk-in-user of the Purchased Product and Journals Shallow Archive in fee based educational programs, use by the Licensee, Authorized or Walk-in User of the Purchased Product and Journals Shallow Archive in the course of research funded by a commercial organization nor use of the Purchased Product and Journals Shallow Archive as a source for or quoting from it in Authorized or Walk-in-User's own scientific, scholarly, and educational works including but not limited to books and articles, is deemed to constitute Commercial Use.
- 1.1.4 **Journals Shallow Archive:** limited archive of a journal included with Purchased Product free of charge. Dates of issues included within each journal's shallow archive differ from journal to journal and are listed in Schedule 2.
- 1.1.5 **License Fees:** combined total of Subscription fees & Purchase fees
- 1.1.6 **Licensee:** an institution listed in Schedule 3 which is represented by the National Library via power of attorney and has agreed to only access and use the Products in accordance with the terms of this Agreement.
- 1.1.7 **Licensor:** The Chancellor, Masters, and Scholars of the University of Cambridge acting through its department Cambridge University Press & Assessment of Shaftesbury Road, Cambridge CB2 8EA, UK.
- 1.1.8 **Online Access:** access to the Products on the Server.
- 1.1.9 **Products:** as applicable, Purchased Products and Subscription Products.
- 1.1.10 **Purchase Fees:** the fees set out in Section I for the supply of Purchased Products.
- 1.1.11 **Purchased Product:** journals content published during the years 2024-2025 which Licensee has purchased on a 'perpetual access' basis (i.e. the Licensee pays a one-time licence fee for the right to permanent access to the applicable product). Journals included in this agreement as listed in Schedule 2.
- 1.1.12 **Secure Authentication:** IP based authentication or such other authentication process agreed between Licensee and Licensor from time to time.
- 1.1.13 **Secure Network:** a network (whether a standalone network or a virtual network within the internet) which is only accessible to Authorised Users whose identities are authenticated (with the exception of Walk-in-Users) by Licensee at the time of login by Secure Authentication.
- 1.1.14 **Server:** either Licensor's server or a third-party server designated by Licensor on which Purchased Product, Journals Shallow Archive and Subscription Product are mounted and via which they may be accessed.
- 1.1.15 **Subscription Fees:** the fees set out in Section I for the supply of Subscription Products during the Subscription Period.
- 1.1.16 **Subscription Period:** the period set out in Section I and during which the relevant Licensee and the Authorised Users may access the Subscription Products.
- 1.1.17 **Subscription Products:** products to which Licensee has subscribed for an agreed period. For the purpose of this Agreement, this refers to the OA Publishing Services (as defined in Section III Transformative Agreement Terms) wherein the Licensees may publish an unlimited number of Articles accepted for publication during the Subscription Period in Cambridge Gold OA, Hybrid or Research Open journals without paying an APC for the duration of the Subscription Period.
- 1.1.18 **TDM:** Text and data mining.
- 1.1.19 **Terms of Use:** the permitted uses and restrictions of use of the Products as set out in clauses 3 and 4 of this Section.

**2 LICENCE**

- 2.1 Subject to payment of the Purchase Fees, Licensor grants Licensee a non-exclusive and non-transferable perpetual right to access and use the Purchased Product in accordance with the terms of this Agreement. Subject to the payment of the Subscription Fees, Licensor grants Licensee a non-exclusive and non-transferable right to give each Consortium Member access and use of the Subscription Products in accordance with the terms of this Agreement.
- 2.2 Where Licensor is no longer able to provide Online Access on a permanent basis, it shall provide a copy of the Purchased Product in pdf format (or make reasonable efforts to ensure continued access through Portico, LOCKSS, or a similar third-party archive or such other electronic format as Licensor in its sole discretion determines but which shall be an industry standard format). Licensee agrees and acknowledges that the use of any such electronic copy shall always be subject to the terms of this Agreement. Licensee accepts and acknowledges that, whilst Licensor cannot guarantee continued access to the Purchased Products, in the event a journal volume is transferred to another publisher, Licensor shall use best efforts to negotiate such continued access rights with the new publisher.
- 2.3 Subject to the payment of the Licence Fees, Licensor grants each Licensee a non-exclusive and non-transferable right to access and use of the Subscription Product in accordance with the terms of this Agreement.
- 2.4 Any journal volume to which Licensee has paid via the National Library to have Online Access shall continue to be accessible perpetually, provided that this Agreement is not terminated by the Licensor under clause 10.2 of this Section. This continuing access shall not apply to any content that may be provided to the Licensees free of charge as an additional benefit i.e. Licensees' access to journals shallow archive.

**3 PERMITTED USES**

- 3.1 This agreement shall be deemed to complement and extend the rights of the Licensee, Authorized and Walk-in-Users under the Finnish Copyright law and nothing in this Agreement shall constitute a waiver of any statutory rights held by the Licensee, Authorized and Walk-in-users from time to time under the law or any amending legislation.
- 3.2 In the event that any content included in the Purchased Product and Journals Shallow Archive is in the public domain or has been issued under a Creative Commons or other open license, Licensor shall not place access, use or other restrictions on that content beyond those found in the open license, where applicable.
- 3.3 In the event of any conflict between the Permitted Uses in this section 3 and any terms and conditions communicated to Authorized and Walk-in -Users at the website where the Purchased Product and Journals Shallow Archive is provided this Agreement shall prevail.
- 3.4 Licensee may:
- 3.4.1 Allow Authorized and Walk-in-Users to have access to the Purchased Product and Journals Shallow Archive from the Server via a Secure Network.
  - 3.4.2 Supply for Inter Library Loan purposes to another library or information service to provide for its user part of the Purchased Product and Journals Shallow Archive by post or fax or electronically including but not limited to email for scholarly and educational use but in no case for Commercial Use. The electronic file must be deleted immediately after printing and the user must receive a print copy and not an electronic one.
  - 3.4.3 Display, save electronically, print and share (also on the Licensee's public website) parts of the Purchased Product and Journals Shallow Archive including trademarks, logos and screenshots for the purpose of promotion or for training Authorized and Walk-in-Users.
  - 3.4.4 Produce translations of user guides and other promotional materials available at Licensor website (public or secure) or otherwise received from Licensor, electronically save/deposit such translations on any electronic network including networks open to the public, display and share such translations via any said electronic network for the purpose of promotion or for training Licensee's Authorized and Walk-in-Users and for the use of other Licensees for the same purpose.
  - 3.4.5 Produce audio visual works that include parts of the Purchased Product and Journals Shallow Archive (including trademarks, logos and screenshots), electronically save/deposit such works on any electronic network including networks open to the public, distribute and publicly perform such works via any said electronic network for the purpose of promotion or for training Authorized and Walk-in-Users and for the use of other Licensees for the same purpose.
  - 3.4.6 Provide Authorized and Walk-in-Users with integrated access and an integrated article author, article title and keyword index to the Purchased Product and Journals Shallow Archive and all other similar material licensed from other publishers.
  - 3.4.7 Copy and/or download metadata regarding the Purchased Product and Journals Shallow Archive and make it perpetually available without charge in the following internal or publicly available online systems in Licensee's use:
    - 3.4.7.1 library catalogue(s)
    - 3.4.7.2 information search portal(s) and systems (including but not limited to the national Finna, sector specific or geographical Finnas)
    - 3.4.7.3 national metadata repository Melinda
    - 3.4.7.4 institutional repositories
    - 3.4.7.5 research publications portal(s) including national portals
    - 3.4.7.6 institutional research information systems (CRIS) including national systems
  - 3.4.8 Only metadata regarding materials authored or co-authored by the Licensee's faculty, students, staff, or affiliated researchers may be used for institutional repositories, research publications portals and institutional research information systems.
  - 3.4.9 The Licensee is permitted to distribute the metadata under Creative Commons Zero –license (CC0 1.0 Universal).
  - 3.4.10 Allow the Purchased Product and Journals Shallow Archive to be searched by Authorized and Walk-in-Users via Finna or other portal in the Licensee's use provided that the terms of this Agreement are upheld.
  - 3.4.11 Gather usage data via Finna or other information retrieval portal in the Licensee's use.
- 3.5 Authorized Users and Walk-in-Users may for Educational and administrative Purposes:
- 3.5.1 Search, retrieve, download, view and display the Purchased Product and Journals Shallow Archive.
  - 3.5.2 Electronically save copies of parts of the Purchased Product and Journals Shallow Archive.
  - 3.5.3 Print off single copies of parts of Purchased Product and Journals Shallow Archive.
  - 3.5.4 share single copies of parts of the Purchased Product and Journals Shallow Archive in print or electronic form including email to third parties outside the Licensee for the purposes of scientific research and communication or to be used for the basis of discussion groups.
  - 3.5.5 Publicly display or publicly perform parts of the Purchased Product and Journals Shallow Archive as part of a presentation at a seminar, conference, or workshop, or other such similar activity.
  - 3.5.6 Reading impaired Authorized and Walk-in-Users may use Braille displays, voice synthesizers and other devices to enable use of the Purchased Products and Journals Shallow Archive.
  - 3.5.7 Extract and use excerpts from the Purchased Product and Journals Shallow Archive for academic research, scholarship, and other educational purposes, including extraction and manipulation for the purpose of illustration, explanation, example, comment, criticism, teaching, research, and analysis.
  - 3.5.8 Use, with appropriate credit, figures, tables, and brief excerpts from the Purchased Product and Journals Shallow Archive in the Authorized User's own scientific, scholarly, and educational works including but not limited to books and articles.
- 3.6 Authorized Users may:
- 3.6.1 Make a reasonable number of photocopies of parts of the Purchased Product and Journals Shallow Archive.
  - 3.6.2 Share parts of the Purchased Product and Journals Shallow Archive in print or electronic form including email to other Authorized and Walk-in-Users. This shall include sharing a copy for teaching purposes to each individual student Authorized User taking part in a course at the Licensee's institution.
  - 3.6.3 Incorporate parts of the Purchased Product and Journals Shallow Archive in printed and electronic course packs, study packs, resource lists and in any other material (including but not limited to multi-media works) to be used in the course of instruction and/or in virtual and managed environments (including but not limited to virtual learning environments, managed learning environments, virtual research environments and library environments) hosted on a Secure Network. Each item shall carry appropriate acknowledgement of the source,

listing title and copyright owner. Course packs in non-electronic non-print perceptible form, such as Braille, may also be offered to Authorized Users who, in the reasonable opinion of the Licensee, are reading impaired.

3.6.4 Incorporate parts of the Purchased Product and Journals Shallow Archive in printed or electronic form in Academic Works, including reproductions of the Academic Works for personal use and library deposit, if such use conforms to the customary and usual practice of the Licensee. Reproductions in printed or electronic form of Academic Works may be provided to sponsors of such Academic Works. Each item shall carry appropriate acknowledgement of the source, listing title and copyright owner.

3.7 Authorised Users may use the Purchased Product and Journals Shallow Archive for the purposes of TDM in accordance with local legislation particularly section 13b (263/2023) of the Copyright Act (404/1961).

3.8 Authorised Users may use the results of their TDM in their research and make the results of their TDM publicly available, provided that no Purchased Product and Journals Shallow Archive or part of a Purchased Product and Shallow Archive is reproduced within such research, other than as permitted by applicable law.

#### 4 RESTRICTIONS

4.1 Except in the course of exercising rights specifically granted in this Agreement or other prior written consent or permitted under any applicable Creative Commons license or copyright law, the Licensee shall not:

4.1.1 remove or alter Licensor's copyright notice or other means of identification or disclaimers as they appear on a Purchased Product or Journals Shallow Archive;

4.1.2 systematically make printed or electronic copies of the Purchased Product or Journals Shallow Archive;

4.1.3 permit access to the Products to anyone who is not an Authorised User;

4.1.4 display or distribute any part of a Purchased Product or Journals Shallow Archive on any electronic network, (including without limitation the internet and the world wide web) other than the Secure Network;

4.1.5 use all or any part of a Purchased Product or Journals Shallow Archive for Commercial Use;

4.1.6 modify, adapt, or alter a Purchased Product or Journals Shallow Archive or make available a Purchased Product or Shallow Archive in any other form or medium or create derivative works from a Purchased Product or Journals Shallow Archive;

4.1.7 create a database in electronic or structured manual form by downloading and storing any content from the Purchased Product or Journals Shallow Archive;

4.1.8 attempt to interfere with the proper workings of any online provision of the Products including attempting to circumvent security, tamper with, hack into or otherwise disrupt or compromise the functionality or availability of the Server or other internet-connected device used as part of Licensor's IT system which enables access to the Products;

4.1.9 subject to clause 4.3, individually download Purchased Product or Journals Shallow Archive content at rate which may reasonably be regarded as excessive.;

4.1.10 use any automated retrieval devices (such as web robots, wanderers, crawlers, spiders or similar devices) save that this is not intended to prevent a Licensee from using a federated search engine or discoverability service as part of its library information services; nor

4.1.11 otherwise download, store, reproduce, transmit, display, print, copy, distribute, extract, exploit or use the Purchased Products or Journals Shallow Archive.

4.1.12 supply the whole or part of any Purchased Product or Shallow Journals Archive to another institution or library.

4.2 The parties shall discuss in good faith any concerns regarding high volume of usage under clause 4.1.9. If, following discussion by the parties, a resolution is not reached or the high volume of usage is not considered to be legitimate, the Licensor reserves the right to withdraw access to the ip-address from with the high volume usage was generated. The high volume usage is detected by an automatic abuse detection process. Upon activation of the process, e-mails including details of the actual download rate detected will be sent to Licensor's administrator, following which Licensor may contact Licensee's administrator to request an investigation. Licensor shall only restore access to the ip-address in question once the issue has been resolved to its satisfaction.

#### 5 LICENSEE'S RESPONSIBILITIES

5.1 Licensee, shall via the National Library, provide the Licensor with all necessary identifying information, including IP address ranges, relating to it and its Secure Network necessary to enable Licensor to set up and activate Online Access. Online Access is conditional upon this information being supplied to Licensor, and Licensee promptly notifying Licensor of any changes to this information.

5.2 Licensee confirms that the range of IP addresses provided further to clause 5.1 of this Section are only assigned to devices within each Licensee's Secure Network.

5.3 Licensee shall use reasonable efforts to:

5.3.1 ensure Online Access is only granted to Authorised Users via the Secure Network. Licensee shall terminate access for any individual who ceases to be an Authorized User for any reason without undue delay according to Licensee's internal policies.

5.3.2 inform Authorised Users of the Terms of Use;

5.3.3 ensure that all Authorised Users treat all logins, passwords or other Authorised User identification required for Online Access as confidential and do not disclose them to any other person;

5.3.4 Licensee shall promptly notify Licensor on becoming aware of any unauthorised use or other breach of this Agreement and take appropriate action (including possible disciplinary action) to ensure that such activity ceases and to prevent any recurrence.

5.4 Nothing in this Agreement shall make the Licensee liable for breach of the terms of the Agreement by any Authorized-User provided that the Licensee did not cause, knowingly assist or condone the continuation of such breach after becoming aware of an actual breach having occurred.

5.5 Licensee is responsible for obtaining at its own cost all internet connections, equipment and software necessary to access the Products via the Secure Network. Furthermore, whilst Licensor will use commercially reasonable endeavours to guard against viruses, it does not guarantee or warrant that any Products or Online Access will be free from infections, viruses and/or other code that has contaminating or destructive properties and Licensee is responsible for implementing sufficient procedures and virus checks to satisfy its requirements for the security of data input and output.

## 6 LICENSOR'S RESPONSIBILITIES

- 6.1 Licensor shall, subject to payment of the Purchase Fees:
- 6.1.1 provide each Licensee with Online Access save for scheduled maintenance or upgrade windows; and
  - 6.1.2 ensure that the Server has sufficient capacity and rate of connectivity to provide Licensee with a level of service which is commensurate with the current standards in the online information industry sector.
- 6.2 Licensor may temporarily suspend Licensee's Online Access for the purposes of maintenance or upgrades but shall use its commercially reasonable endeavours to notify Licensee of such activities and to minimise the period of suspension or interruption.
- 6.3 In relation to any Purchased Product and Journals Shallow Archive made available via Online Access, Licensor reserves the right at any time on notice to Licensee to:
- 6.3.1 make changes or corrections and to alter or update any aspect of the Purchased Product or Journals Shallow Archive;
  - 6.3.2 vary the technical specification of the Purchased Product or Journals Shallow Archive or of any software included therein, provided that the Purchased Product and Journals Shallow Archive remains accessible via the internet using a browser without the need for additional software subject to Section 2. For avoidance of doubt, no change in the method of authentication is possible without an amendment to this Agreement; and
  - 6.3.3 withdraw the Purchased Product (or any part of a Purchased Product) where it has decided to cease publication of that Purchased Product. For avoidance of doubt, volumes published prior to the withdrawal shall continue to be accessible perpetually.
- 6.4 The Licensor shall give written notice to the National Library acting on behalf of the Licensee of such withdrawal 90 days prior to the withdrawal. If the withdrawn material represents more than five percent (5%) of the Purchased Product the Licensor shall make a pro rata refund/reduction of the Purchase Fee, taking into account the amount of material withdrawn and the remaining unexpired portion of this Agreement. Alternatively, if the withdrawal results in the Products being materially less useful to the Licensee, it may within thirty days of such notice treat such changes as a material breach of this Agreement. The provision of a refund (reduction in price) shall discharge Licensor's liabilities to Licensee in respect of the withdrawn Purchased Product (or part of a Purchased Product).
- 6.5 For such period that a Licensee is entitled to Online Access, Licensor agrees to provide the National Library and Licensee with access to usage data and, where available, usage reports detailing the level of use of any Products by Licensee and Authorised Users per month. Any reports made available shall be COUNTER compliant, and such reports and data will not identify individual Authorised User usage but will be provided in respect of the IP address ranges provided further to clause 5.1 of this Section. Licensor will not be able to provide accurate usage data and/or reports if Licensee stores any of the Products on any cache or proxy server, which is discouraged in any event due to the dynamic nature of the Products.
- 6.6 The Licensee acknowledges that the Licensor supports assistive software or devices such as large-print interfaces, text-to-speech output, refreshable braille displays, voice-activated input, and/or alternate keyboard or pointer interfaces in a manner consistent with the Web Accessibility Initiative Web Content Accessibility Guidelines 2.0 AA <https://www.w3.org/WAI/standards-guidelines/>). Licensor shall use best efforts to comply with these standards for content published during the term of this licence. In the event that the Licensor does not meet the standards set forth in by Licensee's interpretation of WCAG 2.0 AA, the Licensor will work with the Licensee and its staff to address any concerns. If any of the Products does not comply, the Licensor shall adapt the Products in a timely manner and at no cost to Licensee to comply with applicable law.

## 7 INTELLECTUAL PROPERTY RIGHTS

- 7.1 Products, usage data and usage reports are protected by international copyright laws, database rights and other intellectual property rights. Licensor, its affiliates and licensors are the owners of these rights, and this Agreement does not transfer any right, title or interest in the Products to Licensee. For the avoidance of doubt, the Licensee shall have the right to use the usage data and usage reports for its own purposes, including but not limited to published reports.
- 7.2 Licensor warrants that it has the right to license the Products and content provided free of charge as an additional benefit i.e. journals shallow archive under the terms stated in this Agreement and that use of the Products and shallow archive access in accordance with these terms does not infringe the intellectual property rights of any third party.
- 7.3 The Licensor shall indemnify and hold the Licensee harmless from and against any loss, damage, cost, liability or expense (including legal and professional fees) arising out of any legal action taken against the Licensee claiming actual or alleged infringement of third-party intellectual property rights. This indemnity shall survive the termination of this agreement for any reason.

## 8 LIMITATION OF LIABILITY

- 8.1 Whilst Licensor shall use commercially reasonable endeavours to provide Online Access, it cannot guarantee that Online Access will operate continually or without interruption, and neither does Licensor guarantee the accuracy of any information and/or content contained in the Products, which are provided on a strictly 'as is' basis. Licensor has no liability for any loss or damage whatsoever sustained by Licensee, a Licensee or any Authorised User as a result of the availability or use of or reliance on the content in the Products. Licensor shall restore access as soon as possible in the event of an interruption or suspension of the service. If the online access is continuously interrupted for a period of five (5) business days or more due to failure on the Licensor's side, the Licensor shall refund (or reduce the Purchase Fee if not yet invoiced) to the Licensee that part of the Purchase Fee that is in proportion to the time that the Purchased Product has not been available due to interruptions in the Online Access.
- 8.2 Save as expressly provided otherwise in this Agreement, Licensor, to the fullest extent permitted by law, excludes all express or implied terms, conditions, warranties and/or representations with regard to the Products including, without limitation, any warranties relating to quality or fitness for purpose.
- 8.3 Neither Licensor nor Licensee shall be liable for any indirect or consequential loss or damage or for any loss of or corruption of data, loss of programs, profit, anticipated savings, revenue or goodwill (whether direct or indirect) arising out of or in connection with the access, availability, use of or reliance on the Products.
- 8.4 The Parties agree that the entire liability of one Party to the other for any claim (whether in contract, tort, misrepresentation, breach of statutory duty or otherwise), excluding indemnity provision 7.3., arising out of or in connection with the access, availability, use of, or reliance on a Purchased Product shall be limited to the Fees paid for that Purchased Product in the year in which the liability arose in relation to that Purchased Product.
- 8.5 Nothing in this Agreement shall limit or exclude Licensor's liability for death or personal injury resulting from Licensor's negligence or its fraudulent misrepresentation or any other liability which cannot be limited or excluded under applicable law.
- 8.6 FOR THE AVOIDANCE OF DOUBT EACH LICENSEE (MEMBER OF THE FINELIB CONSORTIUM) WILL ONLY BE LIABLE FOR ITS OWN ACTIONS AND/OR DEFAULTS.



**9 FEES**

- 9.1 The License Fees are net of all applicable taxes, including without limitation VAT or other applicable sales taxes, which shall be charged in accordance with the relevant regulations in force at the time of making the taxable supply, and such amounts shall be payable by Licensee in addition to the License Fees on receipt of a valid tax invoice.
- 9.2 Each Licensee warrants that it is registered for VAT in Finland, and will promptly inform Licensor in the event that this changes. Where applicable, value-added taxes will be assessed under Finnish law, unless the law of another jurisdiction applies due to a Licensee de-registering for VAT in Finland. If upon audit Licensor is assessed additional value-added taxes in connection with this Agreement because a Licensee is found not to be registered for VAT in Finland, Licensor reserves the right to invoice the applicable Licensee retroactively for any additional associated assessment for value-added taxes.
- 9.3 The National Library is responsible for payment of any value added tax payable to the Finnish tax authority. The National Library shall pay all amounts due to the Publisher without any deduction and/or withholding other than such amount (if any) it is required to deduct and/or withhold by law and/or upon other direction of any tax authority. In the event the National Library is required to make such deduction and/or withholding, the National Library shall notify the Publisher promptly on becoming aware of such requirement.
- 9.4 Licensee shall pay the License Fees annually via the National Library within 60 days of the receipt of invoice. Without prejudice to any other right or remedy that Licensor may have, where Licensee fails to pay the License Fees and any VAT or other applicable Finnish sales tax on the due date, Licensor shall be entitled to:
- 9.4.1 charge interest at a rate of 4% per annum above the base lending rate of Barclays Bank plc, accruing on a daily basis until the date of actual payment; and
- 9.4.2 suspend access to the Products previously granted until full payment is made of any License Fees, and Licensee agrees that the Agreement shall not be extended by any period of delay or suspension resulting from late payment.

**10 TERM AND TERMINATION**

- 10.1 The Agreement may be renewed by mutual consent for additional periods.
- 10.2 Either party may terminate this Agreement immediately by serving written notice on the other in the event that the other party commits a material breach of this Agreement, and in the case of a breach capable of remedy fails to remedy the same within 30 days of a written request to do so. Licensee or an Authorised User's breach of clauses 4 or 4.1.11 of this Section may be deemed a material breach.
- 10.3 Each Licensee has the right to terminate this Agreement if a change in control of a Licensee occurs, a Licensee merges with or acquires an organization, breaks up or if changes relevant to this Agreement occur in the Licensee's permission to organize higher level education or other legislation regarding the Licensee and relevant to this Agreement.
- 10.4 When the Agreement is terminated for one or more Licensees the respective Licensee(s)' Fee(s) will be removed from the Fee Schedule.
- 10.5 On termination of this Agreement by the Licensee under clause 10.2 of this Section, Online Access to the Purchased Products shall continue on a perpetual access basis, as appropriate, unless Licensor is unable to provide such access, in which case the relevant provisions in clause **Error! Reference source not found.** of this Section shall apply. This excludes the complimentary Journals Shallow Archive.

**11 ANTI-BRIBERY AND CORRUPTION**

- 11.1 The National Library agrees that it is subject to and will comply with all applicable laws in Finland, including the Criminal Code of Finland which prohibits bribery and corruption, in the performance of this Agreement. Licensor agrees that it is subject to and will comply with all applicable laws in the United Kingdom related to the prevention of bribery and corruption in the performance of this Agreement. Each party further agrees that it shall not act, or omit to act, in such a way as to give rise to a breach by it, or any of its Affiliates, of any applicable law related to bribery, corruption or any related matter.

**12 SANCTIONS**

- 12.1 Licensor confirms that it is currently not the subject or target of any sanctions imposed by the sanctions' authority of the European Union or the United Nations. Licensor will inform the National Library without delay if there is any change in its sanction's status. If there is a change in the aforementioned sanctions status the Licensee has the right to terminate this Agreement with immediate effect and receive a pro-rated refund of any License Fees paid.

**13 DATA PROTECTION**

- 13.1 If at any time during the term of the Agreement the Commission implementing decision of 28.6.2021 pursuant to Regulation (EU) 2016/679 of the European Parliament and of the Council on the adequate protection of personal data by the United Kingdom is no longer in force, and agreement over entering into the European Commission standard contractual clauses (SCC controller to controller) cannot be reached, Licensee may terminate this Agreement with notice to Licensor and receive a refund of any prepaid but unused License Fees.

**14 CONFIDENTIALITY**

- 14.1 In the course of negotiating the terms of this Agreement, Licensor shall from time to time disclose to Licensee information that is proprietary or confidential to Licensor. Licensee agrees not to disclose information it receives in pre-contractual negotiations in a way that could be prejudicial to Licensor, except as may be required by law, a court of competent jurisdiction or any governmental or regulatory authority. This clause shall survive the termination of this Agreement.
- 14.2 This said, this Agreement including all Schedules is not considered confidential. Licensor acknowledges that the National Library and/or Licensee (s) is intending to publish the Agreement including all Schedules.

**15 GENERAL**

- 15.1 Licensee may not assign, transfer or sub-license its rights or obligations under this Agreement.
- 15.2 Neither party's delay or failure to perform any provision of this Agreement, as result of circumstances beyond its control (including, but not limited to, war, strikes, natural disasters, governmental restrictions, power, telecommunications or Internet failures, or damage to or destruction of any network facilities) shall be deemed to be, or to give rise to, a breach of this Agreement.
- 15.3 This Agreement constitutes the entire agreement between the parties and supersedes any previous agreement between the parties relating to its subject-matter. Each party acknowledges and agrees that, in entering into this Agreement, it does not rely on, and shall have no remedy in respect

- of, any statement, representation, warranty or understanding (whether negligently or innocently made) other than as expressly set out in this Agreement.
- 15.4 This Agreement may not be amended, varied or supplemented except in writing signed by duly authorised representatives of both parties.
- 15.5 If any provision of this Agreement (or any part of any provision) is found by a court to be unenforceable that provision or part provision shall, to the extent required, be deemed not to form part of this Agreement and the validity and enforceability of the other provisions of this Agreement shall not be affected.
- 15.6 No provision of this Agreement is intended to be enforceable by a person who is not a party to this Agreement.
- 15.7 Any notice given to a party under or in connection with this Agreement shall be in writing and shall be delivered by hand or by pre-paid first-class post or other next business day delivery service at its registered office (if a company) or its principal place of business (in any other case) or sent by e-mail, if to Cambridge at **generalcounsel@cambridge.org**, and if to the Licensee, at the e-mail address in Section I. Any notice shall be deemed to have been duly received: if delivered by hand, on signature of a delivery receipt or at the time the notice is left at the proper address; if sent by pre-paid first-class post or other next business day delivery service, at 9.00 am on the second business day after posting or at the time recorded by the delivery service; if sent by e-mail, at 9.00 am on the next business day after transmission. This clause does not apply to the service of any proceedings or other documents in any legal action or, where applicable, any arbitration or other method of dispute resolution.
- 15.8 The rights of the parties arising under this Agreement shall not be waived except in writing. Any waiver of any of a party's rights under this Agreement or of any breach of this Agreement by the other party shall not be construed as a waiver of any other rights or of any other further breach.
- 15.9 Headings used in this Agreement are for convenience only and are deemed not to be part of the Agreement.
- 15.10 This Agreement is drafted in the English language. If this Agreement is translated into any other language in the event of conflict the English language version shall prevail.
- 15.11 This Agreement and any dispute or claim arising out of or in connection with it or its subject matter or formation (including non-contractual disputes or claims) is subject to Finnish Law. The parties submit to the non-exclusive jurisdiction of the Finnish courts to settle any dispute or claim arising out of or in connection with this Agreement or its subject matter or formation (including non-contractual disputes or claims).



**SECTION III TRANSFORMATIVE AGREEMENT TERMS**
**1 DEFINITIONS**

1.1 This Section uses the following defined terms:

- 1.1.1 **Article:** a research, case report, brief report, review or rapid communications format article (as defined by Licensor).
- 1.1.2 **Article Processing Charges (APCs):** the fee a publisher will sometimes charge for making articles Open Access.
- 1.1.3 **Cambridge Core:** Licensor's online platform for books and journals.
- 1.1.4 **Cambridge OA Journals:** journals which offer an OA publishing option as listed in Schedule 2.
- 1.1.5 **Corresponding Author:** an Authorized User (excluding Walk In Users) affiliated with the Licensee who handles the manuscript and correspondence during an Article's publication process – from manuscript correction and proof reading, to the revisions and re-submission of revised manuscripts up to acceptance. They (a) have the authority to act on behalf of all co-authors in all matters pertaining to publication of the manuscript including supplementary material (b) are responsible for informing the co-authors of the manuscript's status throughout the submission, review, and publication process and (c) act as the point of contact for any enquiries after an Article is published.
- 1.1.6 **Creative Commons Licence:** a type of licence allowing an author to communicate which rights they reserve and which they agree to waive in order to enable end-users to benefit from a gratis right to reproduce and distribute (and make derivative works from) the original Article. Licensor offers CC BY, CC BY-SA, CC BY-NC, CC BY-ND, CC BY-NC-SA, and CC BY-NC-ND (all 4.0 or newer version) each described in more detail on the Creative Commons website.
- 1.1.7 **Open Access/OA:** a publishing model that allows content to be published digitally and made accessible without charge to the end-user (subject to the terms of an applicable Creative Commons Licence).
- 1.1.8 **OA Publishing Services:** the opportunity to publish Articles in Cambridge OA Journals without paying an APC.
- 1.1.9 **Year:** calendar year.

1.2 Any other defined terms in this Agreement shall have the meaning given in the relevant Section.

**2 OA PUBLISHING PROCESS**

- 2.1 Corresponding Authors have the opportunity to publish an unlimited number of OA Articles in Cambridge OA Journals without incurring any Article Processing Charges.
- 2.2 Corresponding Authors publishing OA Articles in Cambridge OA Journals will typically retain the copyright, granting Cambridge (or its journal proprietors) a licence to publish. Where Corresponding Authors do need to assign the copyright in their Article in order to publish in a particular journal, Cambridge will communicate this in an open and transparent way. Cambridge is actively working towards (a) increasing the proportion of journals that use a licence to publish rather than a copyright transfer and (b) a default CC-BY workflow, and will continue to support these objectives by appropriate messaging.
- 2.3 In order to publish in a Cambridge OA Journal, the Corresponding Author must:
  - 2.3.1 have an Article accepted for publication within the Subscription Period; See Schedule 4: Licensor OA Publishing Workflow
  - 2.3.2 provide details of their affiliation with Licensee, when submitting their Article for publication; and
  - 2.3.3 sign a licence to publish form or equivalent documentation, as required by the Cambridge OA Journal publishing the Article, selecting a Creative Commons Licence in the process.
- 2.4 Articles published non-OA in Cambridge OA Journals during the Term of this Agreement will be eligible for retroactive conversion to OA provided:
  - 2.4.1 the Article was accepted for publication during the Subscription Period. See Schedule 4: Licensor OA Publishing Workflow; and
  - 2.4.2 the request to convert to OA is made no more than three months after the Year in which the Article was published (for example, an article published in December non-OA will need to be made retroactively OA by 31 March of the following year. Any conversion requires that the Corresponding Author requests that their article be made OA and signs a new applicable publishing agreement).
- 2.5 Corresponding Authors who have chosen to publish behind a paywall, have the right to retrospectively have their article converted to open access and covered by this Agreement.
- 2.6 Corresponding Authors who have chosen the CC BY, CC BY-SA, CC BY-NC, CC BY-ND, CC BY-NC-SA, and CC BY-NC-ND license have the right to have retrospectively their license changed to CC BY without fee.
- 2.7 Corresponding Authors who have paid their own APC have the right to a refund for paid APC's. Requests must be made within one year of publication.
- 2.8 If a Cambridge OA Journal is transferred to another publisher during the term of this Agreement:
  - 2.8.1 Articles which were accepted for publication will still be published in the Cambridge OA Journal, provided there is space to do so in a journal volume published before the transfer;
  - 2.8.2 All retroactive OA requests must be complete prior to the date of content file transfer to the new OA journal publisher.
- 2.9 Any eligible Hybrid OA Journal listed in Schedule 2 that becomes a Gold OA Journal during the term of this Agreement shall remain eligible for open access publishing for the remainder of the term. Any paywalled journal listed in Schedule 2 that becomes a Hybrid or Gold OA Journal during the term of this Agreement, will be eligible for open access publishing for the remainder of the term.

**3 LICENSOR'S RESPONSIBILITIES**

- 3.1 Licensor shall:
  - 3.1.1 verify the identity of Corresponding Authors after the acceptance of Article manuscripts, via affiliation, email domain, or ORCID.
  - 3.1.2 provide Licensees with a list of the Cambridge OA Journals;
  - 3.1.3 provide reports to each Licensee through the National Library detailing their respective publishing outputs (both OA and paywalled), including the following information: name of Corresponding Author, institutional identifier, article title, DOI, journal title, OA licence applied, Creative Commons Licence (if applicable), date first published online, standard APC amount for each journal title; and
  - 3.1.4 host information relating to the OA publishing opportunities it offers on Cambridge Core.

3.1.5 facilitate retroactive OA publishing under this Agreement, as described in clauses 2.4-2.7 of this Section.

#### 4 LICENSEE'S RESPONSIBILITIES

4.1 Licensee shall inform their researchers and authors about the licensor's OA publishing process as described in this Agreement.

#### 5 EXCEPTIONS AND EXCLUSIONS

5.1 Some of Licensor's journals currently do not permit OA publishing. As such, OA publishing will initially not be available in those journals. These journals will become eligible for OA publishing on an annual basis, if and when OA options are introduced by the journal's proprietors.

5.2 It is not the Licensor's goal to move more content from the standard Full Collection to any of our Gold OA series. However, we cannot ensure that this will not happen in the future. Therefore, the Licensor guarantees that should this happen during the term of this agreement (2024-2025, option year 2026), the Licensor will honour the terms of the deal and the Licensee will continue to be able to publish in the affected journal(s) free of charge under the terms of this Agreement.

#### 6 FEES

6.1 The License Fee is split into two parts to correctly describe the products and services being delivered:

6.1.1 A '**Read**' fee, for the supply of the Purchase Products; and

6.1.2 A '**Publish**' fee, for the provision of the OA Publishing Services

6.2 This split of the License Fee will be calculated based on the comparison of the total list-price value of the Full collection with the value of the total number of eligible articles. Eligible articles are the 5 article types listed in clause 1.1.1. The split will vary from year to year and as journals flip to Gold OA the weighting of the value will move more and more towards the publish part over the course of the agreement. The split of the Subscription Fee is as follows:

2025 and option year 2026	To be agreed in writing at least 30 days before the end of the previous calendar year.

**SCHEDULE 1: ACCESS INFORMATION**

1. Licensee maintains perpetual access rights to all titles in its respective licenced collections for the years paid. This includes not only the institutional journal holdings but also the titles that make up the remainder of the collection. This does not include backfile years that are freely accessible with a current licence i.e. journals shallow archive.
2. The journals shallow archive is included free of charge as long as a license to the annual current content is maintained. Available shallow archive years vary per journal. Upon point of license termination, access to this free content will discontinue.
3. The annual standard Full Journals Collections are hosted on Cambridge Core ([www.cambridge.org/core](http://www.cambridge.org/core)) with access controlled by IP ranges. IP ranges can be updated by Cambridge University Press Customer Services personnel by contacting [academictechsupport@cambridge.org](mailto:academictechsupport@cambridge.org). Please note that Cambridge may check IPs to ensure that they correctly identify the Licensee.
4. All standard sales collections are described in KBART format, plus full title lists of All Journals are available in KBART format for customer use. These can be found at: <https://www.cambridge.org/core/services/librarians/kbart>. Specific KBART files can also be sourced from within your logged-in administrator account on Cambridge Core.

**SCHEDULE 5: LICENSOR OA PUBLISHING WORKFLOW**

1. The current OA publishing workflow is outlined below. This process is continuously evolving and improving and therefore the Licensor reserves the right to change aspects of the workflow at any time provided that such changes will not alter the terms of this Agreement to the detriment of the Licensee or eligible Corresponding Authors.
2. Cambridge verifies the identity of Corresponding Authors after the acceptance of Article manuscripts via, in no particular order, affiliation, email domain, or ORCID.
3. Corresponding Authors are made aware of their eligibility via:
  - a. Journal homepages on Cambridge Core
  - b. Submission information pages for authors on Cambridge Core
  - c. At key touchpoints in our online peer review systems (from log-in right through to article acceptance)
  - d. In a welcome email once an author's paper moves into Production with us
  - e. In a post-publication email to authors once their paper is published on Cambridge Core
4. Where possible based on the system the title is using, Licensor will offer CC-BY preselected as the default option.
5. Further to Section III, clause 2.4.1: eligible articles published under this agreement are based on acceptance date. However, article publishing reporting is based on online publication date as this is the only date that is consistently and systematically recorded. In regard to retroactive OA campaign activity, authors who publish behind a paywall are contacted on a monthly basis based on online publication date. This may include articles that were accepted before the Subscription Period commenced. Should the license not be renewed for the next term, articles that are accepted during the Subscription Period but published in the year in which there was no longer an agreement, these articles would still be eligible to be converted to Open Access under the terms of the license.
6. The Licensor has partnered with Rightslink Agreement Manager to transact each OA article's rejection or acceptance. Licensees can choose to accept or reject articles through one of the three following methods:
  - a. Automatic approval
  - b. Institutional approval
  - c. FinELib approval (conditional on FinELib offering this option)
