

Wolters Kluwer Health (Medical Research) Ltd. Online License Agreement

This Agreement, dated as of the 31st day of December, 2022 ("Effective Date"), between Ovid Technologies GmbH a German company having offices at Leipziger Platz 7, D-10117, Berlin, Germany (hereinafter referred to as "Ovid") and The National Library of Finland, Unioninkatu 36,(P.O.Box 15), FIN-00014 UNIVERSITY OF HELSINKI, Helsinki, Finland ("the National Library") and other members of the FinELib Consortium, the other members of the FinELib Consortium represented by the National Library via a power of attorney (the National Library and other members each hereinafter referred to as "Subscriber" - as such are listed at Schedule D; collectively with Ovid, referred to as the "Parties") provides for use by Subscriber of the Products, as defined below, through Ovid's remote database access service for a fixed fee, subject to the terms and conditions set forth in this agreement (the "Agreement").

1. DEFINITIONS.

- 1.1. "Products" made subject to this Agreement consist of: (i) all "Journals" excluding Neurology that are included in the LWW Total Access Collection ordered by the Subscriber pursuant to Schedule B attached hereto, a current list of which Journals is set forth in Schedule C attached hereto; (ii) the "Software," ordered by the Subscriber pursuant to Schedule B, consisting of the search and retrieval application software and any modifications, enhancements, updates, upgrades or new releases produced by Ovid during the term of the Agreement; (iii) computer capacity to support the site license for the Authorized Site(s) listed in Schedules B and D (iv) subscriber support services, via telephone, facsimile transmission or Internet E-mail. For the avoidance of doubt, this Agreement applies only to Products listed on Schedules B and C to this Agreement.
- 1.2. "Authorized Site(s)" means a Subscriber site composed of (i) single or multiple institutions, (ii) single or multiple geographic locations or (iii) a combination of the aforementioned for which Subscriber requests designation by Ovid as sites authorized to access the Products. A list of Authorized Site(s) for purposes of this Agreement is set forth in Schedules B and D, as such may be amended from time to time. In the event that Subscriber acquires or merges with another related or affiliated entity during the term of this Agreement, such acquired or merged entity may be deemed a separate additional site subject to additional access fees and subscription fees, at Ovid's discretion.
- 1.3 "Authorized Users" mean: (i) Subscriber; (ii) employees of Subscriber, if Subscriber is a corporation or other organization; provided however, that employees of an entity which is acquired by or merged with the Subscriber during the term of this Agreement will not be deemed Authorized Users for purposes of this Agreement without Ovid's consent; (iii) current members of the faculty, staff, employees, affiliated researchers, docents and contractors of the Subscriber (whether on a permanent, temporary, contract or visiting basis), individuals who are studying at a Subscriber institution, walk-in users, at a Subscriber facility if Subscriber is an academic institution, (iv) employees, staff and researchers of Subscriber, if Subscriber is a research institution,

walk-in-users at a Subscriber facility if the Subscriber's library is open to the public. Authorized Users may be persons affiliated with remote site or campuses, but not persons at remote sites or campuses with separate administrations. The applicable user model (e.g., site license, concurrent user, etc.) will be set forth on Schedules B and/or C. For purposes of this Agreement, any institutions, associations or organizations related or affiliated with Subscriber will not be deemed "Authorized Users" without Ovid's express consent.

1.4 "Permitted Use" means use of the Product(s) by Authorized Users only for the purpose of education, teaching, user training, distance learning, private study, retrieving information and/or research ("Educational Purposes").

This Agreement shall be deemed to complement and extend the rights of the Subscriber and Authorized Users under the Finnish Copyright law and nothing in this Agreement shall constitute a waiver of any statutory rights held by the Subscriber or Authorized Users from time to time under the Finnish Copyright law or any amending legislation.

Authorized Users may:

- (i) view and display (also to other Authorized users) the content and data contained therein on computer or projection screens for Educational Purposes;
- (ii) make limited copies of data obtained from searches in print (including photocopies) or electronic format for Educational Purposes;
- (iii) provide limited copies of data obtained from the searches in print or electronic format to other Authorized Users for Educational Purposes but limited solely to such Educational Purposes from an Authorized User to an Authorized User;
- (iv) electronically save data obtained from searches for Educational Purposes;
- (v) distribute copies of parts of the Products in an incidental manner in print or electronic form to third party colleagues for the purposes of non-commercial scholarly communication or to be used for the basis of discussion groups only;
- (vi) use Braille displays, voice synthesizers and other such devices to enable use of the Products by reading impaired Authorized Users;
- (xii) incorporate parts of the Products in electronic Course or Study Packs for the use of Authorized Users in the course of instruction by using a link from Subscriber's web pages or learning platform to the required material on Ovid's platform; Course packs in non-electronic non-print perceptible form, such as audio or Braille, may also be offered to Authorized Users who, in the reasonable opinion of the Subscriber, are reading impaired; and
- (viii) use the Products to perform and engage in data mining activities for Educational Purposes. Data mining is a machine process by which information may be derived by identifying patterns and trends within natural language through text categorization, statistical pattern recognition, concept or sentiment extraction, and the association of natural language with indexing terms.

Authorized Users who are library staff also may:

- (i) print individual articles for Inter-Library Loan whereby articles can be delivered via printing or faxing or through the use of Ariel or a similar system to fulfill Inter-Library Loan requests from an academic, research or other non-commercial library.
- (ii)save electronically and display to Authorized Users only limited parts of the Product (which may incidentally include trademarks, logos and screenshots) for training Authorized Users thereon. Such limited parts may also be displayed by such library staff on public websites operated by Subscriber for the purpose of training Authorized Users;

The Permitted Use expressly precludes (i) copying, duplication, redistribution, retransmission, publication, transfer or commercial or other exploitation of the Product(s), in whole or in part, where such acts are contrary to the Permitted Use; (ii) preparation of derivative works or incorporation of the Products, in whole or in part, in any other work or system; (iii) reverse engineering, decompiling or modification of the Products, in whole or in part; and (iv) uploading, downloading, copying or redistributing the content in their entirety or lengthy sequence.

Commercial means use for the purposes of monetary reward (whether by or for the Subscriber or an Authorized User) by means of the sale, resale, license, loan, transfer, distribution, hire or other form of exploitation of the Products. For the avoidance of doubt, none of the following is deemed to constitute commercial use:

- recovery of direct costs or costs required by law by the Subscriber from Authorized Users or from the receiving library in the case of Inter Library Loan; and
- use by the Subscriber or by an Authorized User of the Products in the course of research funded by a commercial organization.

2. USE OF THE PRODUCTS.

- 2.1. Ovid hereby grants to Subscriber the non-transferable, nonexclusive limited right to gain computerized access using the Software to the Product(s), subject to the terms and conditions of this Agreement. Authorized Users will use the Product(s) only in accordance with the Permitted Use. In addition to the foregoing, Subscriber may display on their websites Ovid trademarks and limited screenshots of the Product(s) on its websites for purposes of informing Authorized Users of the availability of the Product(s) and providing training thereon.
- 2.2. If requested by Subscriber, Ovid will issue Subscriber one or more identification password(s), such number to be determined at Ovid's discretion, to gain access to the Products during Ovid's scheduled hours of service. Where applicable, Subscriber agrees that the identification password(s) is valid only in the country in which it is issued and may be restricted from accessing certain data on the Products. Subscriber may elect to use proxy servers to allow its Authorized Users to access the Products remotely. Subscriber and its Authorized Users will access the Products via IP validation only. Except as provided in Section 5.3 of this Agreement, Subscriber is responsible for all charges against Subscriber's identification password(s). Ovid reserves the right, at its sole discretion, to alter or change Subscriber's identification password(s) as circumstances may warrant.
- 2.3.Ovid will provide administration accounts to the National Library and the Subscriber that allows the National Library and Subscriber to log in, view and analyse usage COUNTER compliant data of searches and in the case of journals downloads monthly per title per organization.
- **2.4.** To improve the use of the subscribed products Ovid will provide Subscriber with online trainings.



- **2.6.** Ovid will make every commercially reasonable effort to ensure that the Products are OpenURL compliant for the term of the agreement.
- 2.7. Ovid understands the importance of accessibility of the Products and works towards achieving it. Ovid will inform the National Library, on request, of the progression of this work. Ovid will use its reasonable endeavors to meet the W3C standards (www.w3.org/WAI/Resources/#in) in order to ensure that the Products are accessible to all Authorized Users.
- **2.8**. Ovid will use reasonable endeavors to provide an OAI-PMH metadata harvesting interface or otherwise provide for harvesting of bibliographic records into an integrated search solution for the Subscriber's use Ovid will also use reasonable endeavors to make the metadata available through the Subscriber's discovery service system.
- **2.9**. Ovid will use reasonable endeavors to adhere to the specifications of the standards http://www.uksg.org/kbart/s5/guidelines).
- **2.10**. Ovid will use reasonable endeavors to adhere to the specifications of the Transfer Code of Conduct (http://www.uksg.org/transfer).
- **2.11** Ovid will use its reasonable endeavours to enable provision of an SFX Link Resolver for the Products through ExLibris. Ovid supports Alma links resolvers.
- **2.12.** Perpetual Access rights. For journals subscribed to during the term of this Agreement, subject to the provisions of the immediately following paragraph of this Section 2.11, Subscriber shall be entitled to the perpetual access rights related to those journals at the time of contract. The current perpetual access policy can be found at in Schedule C. In the event of a conflict between this Section 2.11 and such archive policy, the terms of this Section 2.11 will govern.

The archival rights per journal as currently exist are as set out in Schedule C. Such rights for journals not wholly owned by Ovid or an affiliate of Ovid are subject to change without notification to Subscriber although every reasonable effort will be made to notify Subscriber of such changes in line with Section 16 below. Archival rights to journals wholly owned by Ovid or an affiliate of Ovid are guaranteed for the period of time for which they remain wholly owned by Ovid or any such affiliate of Ovid. If a journal wholly owned by Ovid or an affiliate of Ovid is transferred to a new owner Subscriber will continue to have perpetual access archival rights to issues published prior to the date of transfer. Perpetual access rights will be provided to Subscriber by Ovid via Portico or such other electronic method as Ovid shall determine in its sole discretion, subject to Subscriber's payment of reasonable media, fulfillment, delivery, and/or maintenance fees.

3. PROPRIETARY RIGHTS AND USE RESTRICTIONS FOR THE PRODUCT(S).

- **3.1.** The Software is produced and owned by Ovid; the content is licensed to Ovid under separate agreements between Ovid and certain information providers ("**Information Providers**") and are proprietary to Information Providers. No provision of this Agreement conveys any ownership interest in or to the Products, in whole or in part. Title, as well as applicable copyrights, patents, trademarks, trade secrets or other intellectual property rights in and to the materials in the Products are, and remain the property of Ovid, Information Providers or individual copyright claimants, as applicable.
- **3.2.** No rights to use the Product(s) are conveyed to the Authorized Users except as permitted by this Agreement and, if applicable, pursuant to the user guidelines

produced by Information Providers, as made available by Ovid, from time to time, in electronic or print form.

3.3. Information Providers and / or Ovid may modify or assign additional terms and conditions, as made available to Subscriber by Ovid, from time to time, which affect the Authorized Users' use of the Product(s), including without limitation, changes in subscription rates, use restrictions or guidelines.

- 5. SUBSCRIBER'S OBLIGATIONS. Subscriber agrees to the following:
 - **5.1.**[Intentionally Omitted.]
 - **5.2.** to be responsible for communication costs incurred by any Authorized User connecting to the Product with a valid password;
 - 5.3. to be responsible for the confidentiality and security of the identification password(s) issued to Subscriber by Ovid. Subscriber will not be responsible for charges against any identification password(s) that are lost or stolen; provided Ovid has received prompt notice to such effect;
 - **5.4.** if reasonably requested by Ovid to designate in writing a staff member to be "System Administrator" (project manager) for the purpose of resolving implementation questions, such person to be available to Ovid on a routine and expedited basis when necessary;
 - **5.5.**Use reasonable endeavors to ensure that all Authorized Users are appropriately notified of the importance of respecting the intellectual property rights in the Products and of the sanctions which Subscriber imposes for failing to do so;
 - 5.6.Use reasonable endeavors to notify Authorized Users of the terms and conditions of this Agreement and take steps to protect the Products from unauthorized use or other breach of this Agreement;
 - **5.7.**Immediately upon becoming aware of any unauthorized use or other breach, inform OVID and take all reasonable and appropriate steps, including disciplinary action, both to ensure that such activity ceases and to prevent any recurrence;
 - **5.8.** Use reasonable endeavors to ensure that only Authorized Users are permitted access to the Products;

6. LIMITED WARRANTIES AND LIMITED LIABILITIES.

- **6.1.**Ovid represents and warrants that it has the complete right and authority to enter into this Agreement and to deliver the Products "**AS IS**".
- **6.2.**As a consequence of factors affecting the transmission of the Products which are beyond Ovid's control, Ovid will not guarantee performance of the Products through the Internet or other transmission modes.
- 6.3.OVID AND INFORMATION PROVIDERS EXPRESSLY DISCLAIM AND EXCLUDE ALL WARRANTIES (INCLUDING WITHOUT LIMITATION, MERCHANTABILITY AND FITNESS FOR A PARTICULAR PURPOSE, AND REPRESENTATIONS, WHETHER EXPRESS OR IMPLIED, IN RELATION TO THE PRODUCTS, THE CONTENT CONTAINED THEREIN AND THEIR PROVISION UNDER THIS AGREEMENT. ALTHOUGH DUE CARE IS USED IN PREPARING THE PRODUCTS, OVID AND INFORMATION PROVIDERS MAKE NO WARRANTIES THAT ACCESS TO THE PRODUCT(S) WILL BE UNINTERRUPTED OR THAT THE PRODUCTS WILL MEET SUBSCRIBER'S REQUIREMENTS, OR THAT THE CONTENT IS ACCURATE OR COMPLETE OR THAT THE RESULTS OBTAINED BY ANY AUTHORIZED USERS WILL BE ERROR FREE. NO OVID EMPLOYEE OR AGENT IS AUTHORIZED TO MAKE ANY STATEMENT THAT ADDS TO OR AMENDS THE WARRANTIES OR LIMITATIONS CONTAINED IN THIS AGREEMENT.
- 6.4. NONE OF OVID, ITS AFFILIATES OR INFORMATION PROVIDERS, NOR ANY OF DIRECTORS, THEIR RESPECTIVE OFFICERS, **EMPLOYEES.** DISTRIBUTORS, SUBCONTRACTORS, SUPPLIERS OR AGENTS, WILL BE LIABLE TO SUBSCRIBER, OR AUTHORIZED USERS FOR LOSS OF PROFITS, LOSS OF USE OR FOR ANY INDIRECT, SPECIAL OR CONSEQUENTIAL DAMAGES WHETHER BASED UPON A CLAIM OR ACTION OF CONTRACT, WARRANTY, **NEGLIGENCE, STRICT LIABILITY OR OTHER TORT, EVEN IF THEY ARE AWARE** OF THE POSSIBILITY THEREOF. FURTHER, SUBSCRIBER AGREES THAT. **EXCEPT FOR OVID'S INDEMNIFICATION OBLIGATION EXPRESSLY SET FORTH** IN SECTION 7.2 OF THIS AGREEMENT OR DAMAGES CAUSED BY OVID'S WILLFUL MISCONDUCT OR GROSS NEGLIGENCE, THE ENTIRE LIABILITY OF OVID, ITS AFFILIATES AND INFORMATION PROVIDERS, AND ITS AND THEIR EMPLOYEES, RESPECTIVE DIRECTORS, OFFICERS, DISTRIBUTORS, SUBCONTRACTORS, SUPPLIERS OR AGENTS AND THE EXCLUSIVE REMEDY OF THE SUBSCRIBER OR ANY THIRD PARTY, WILL IN NO EVENT EXCEED AN AMOUNT EOUAL TO THE TOTAL FEES PAID BY SUBSCRIBER TO OVID FOR THE USE OF THE PRODUCTS IN THE TWELVE-MONTH PERIOD PRECEDING THE DATE ON WHICH THE FIRST CLAIM OR CAUSE OF ACTION AROSE. FOR CLARITY, OVID'S OBLIGATION TO DEFEND SUBSCRIBER, AND LOSSES, DAMAGES, LIABILITIES, EXPENSES AND COSTS PAYABLE BY OVID, UNDER SECTION 7.2, WILL BE REGARDED AS DIRECT DAMAGES, REGARDLESS OF HOW THOSE LIABILITIES ARE CATEGORIZED.
- 6.5.FOR THE AVOIDANCE OF DOUBT EACH SUBSCRIBER (MEMBER OF THE FINELIB CONSORTIUM) WILL ONLY BE LIABLE FOR ITS OWN ACTIONS AND/OR DEFAULTS.
- **6.6.**Neither Ovid nor its employees and agents will be liable for assistance provided to Authorized Users in performing research using the Products and any such assistance received from Ovid employees or agents will be solely at Authorized Users' risk.
- **6.7.** Authorized Users, including physicians, health care workers and other professional persons using the Products MAY NOT rely on the information contained in the Products.

Alternatively, they must rely on their clinical discretion, judgment and expertise in diagnosis and treatment.

6.8. Any cause of action brought by any party to this agreement concerning the Products must be commenced within one (1) year after such cause of action has accrued.

7. INDEMNIFICATION.


- **7.1.**Ovid warrants and represents that, it is the owner of the copyright in the Products or that it is duly licensed to use the copyrighted material contained in the Products and that, the Products used as contemplated in this Agreement does not infringe any copyright or other proprietary or intellectual property rights of any natural or legal person. Subscriber's sole and exclusive recourse and remedy, and Ovid's sole, exclusive and entire liability, for any breach of the foregoing warranty is the indemnity set forth in Section 7.2.
- 7.2. OVID shall indemnify and hold the Subscriber harmless from and against any loss, damage, cost, liability or expense (including reasonable legal and professional fees) arising out of any legal action taken against the Subscriber claiming actual or alleged infringement of such rights, provided, that (a) Ovid is notified promptly in writing of the claim; (b) Ovid controls the defense and settlement of the claim; and (c) Subscriber cooperates with all reasonable requests of Ovid (at Ovid's expense) in defending or settling the claim. This indemnity shall survive the termination of this Agreement for any reason. This indemnity shall not apply if the Subscriber or an Authorized User has: (i) amended or used the Products in any way not permitted by this Agreement, and such amendment or use has caused the loss, damage, cost liability or expense; (ii) used a superseded or altered version of some or all of the Products if infringement would have been avoided or mitigated by the use of a subsequent unaltered version that is provided to Subscriber: (iii) not use a correction provided by Ovid if infringement would have been avoided or mitigated by the use of such a correction. If all or part of the Products become, or in Ovid opinion, are likely to become, the subject of a third party claim of infringement or violation of such third party's intellectual property rights, Ovid may, at its option (i) procure for Subscriber the right to continue using the Products, (ii) except in the event the entire LWW Total Access Collection becomes infringing, replace the same with a non-infringing Products of substantially equivalent functionality, or (iii) modify the Products so that they become non-infringing without materially reducing their functionality. If Ovid determines that none of the foregoing alternatives are feasible or commercially reasonable, Ovid may terminate Subscriber's license to the Products and provide Subscriber with a pro-rata refund of prepaid but unearned fees paid for the Products. To the maximum extent permitted by applicable law, the provisions of this Section 7.2 sets forth Subscriber's sole remedy, and Ovid's sole liability, for any breach of the warranty set forth in Section 7.1.
- **8. PAYMENT.** Annual total prices for the use of the Product: for year 2023 EUR 955,673.00 and for year 2024 EUR 1,027,347.00. The allocation of the total prices per Subscriber for use of the Products are set forth in Schedule B. Payment for 2023 will be invoiced upon the execution of this Agreement. Payment for 2024 will be invoiced one (1) year from the Effective Date. All invoices are due event that Subscriber fails to make prompt payment, Ovid reserves the right to deny access to the Products until such time as Subscriber's account is made current. Subscriber will be responsible for the payment of all taxes and similar assessments, or other related fees incurred to the Subscriber in connection with this Agreement. If Subscriber shall fail to make any required payment within ten (10) days from the date the same become due and payable, such unpaid amounts shall bear interest from the due date thereof to the

date of payment at the rate of eighteen percent (18%) per annum or the highest rate permitted by applicable law, whichever is less.

- **9. TERM.** The term of this Agreement is December 31st, 2022 until December 31st 2024.
- **10.TERMINATION.** If Ovid or any one of the Subscribers is in breach of the terms and conditions of this Agreement, the breaching party will have ten (10) business days in which to cure the breach. If the breaching party has not cured the breach, the non-breaching party may terminate this Agreement, in addition to pursuing all other legal remedies. The provisions of this Agreement which protect the proprietary rights of Ovid and Information Providers as well as clauses 2.11 and 7 will continue in force after termination. Additionally, clauses 1.3 and 1.4 will continue in force after termination, but only to the extent necessary to allow Authorized Users perpetual access granted to such Authorized Users under this Agreement, subject to the limits of such perpetual access set forth in this Agreement. Any termination, whether or not for breach, will not affect any right, obligation or liability of a party arising prior to termination of the Agreement. If any of Subscribers is in breach and such breach is not cured within ten (10) business days Ovid has the right to immediately terminate this Agreement with respect to such breaching Subscriber and pursue all legal action necessary against that Subscriber without affecting the rights and obligations of the remaining Subscribers under this Agreement

Publisher claims as business secret . Subscribers shall provide to Ovid all reasonable cooperation and assistance that Ovid may request in the enforcement of Ovid's rights against an infringing member-Subscriber.

- **11.ENTIRE AGREEMENT; AMENDMENT.** This Agreement (including all appendices) will constitute the entire agreement of the Parties. It is expressly agreed that any terms of a purchase order or similar instrument issued by Subscriber with respect to this Agreement will not affect the terms and conditions of this Agreement. This Agreement may not be modified or amended except by written consent of the Parties or in accordance with the provisions set forth in Subsection 3.3. of this Agreement.
- **12.NOTICES.** All notices, consents or other communications referred to herein will be in writing and will be conveyed to the other party by First Class Mail or electronically at the appropriate addresses indicated in Schedule A by the Parties. Service of such notice, consent or other communication hereunder will be effective on the fifth day after the day of mailing or the same day as the day of transmission.
- **13.FORCE MAJEURE.** Neither party will be liable for any delay, failure in performance or interruption of service due to any unforeseen circumstances or circumstances beyond its control, including, without limitation, war, strikes, civil disturbances and Acts of God.
- **14.SEVERABILITY.** If a term or condition of this Agreement is found by a court or administrative agency to be unenforceable, the remaining terms and conditions will remain in full force and effect.
- **15.GOVERNING LAW.** This Agreement will be governed by the laws of the State of New York, without giving effect to the principles of conflict of law thereof. Any dispute, controversy or claim arising between the parties of this agreement under or in connection with this agreement shall be settled in arbitration in accordance with the Rules of Arbitration Committee of the Finnish Central Chamber of Commerce pursuant to the regulations in force. The arbitration shall take place in Helsinki, Finland, in the English language.
- **16.UPDATES AND DISCONTINUATION**. Subscriber acknowledges that Ovid may update, modify, or replace Journals included in the Product, including in the event that Ovid loses



18.SANCTIONS. Ovid confirms that it is currently not the subject or target of any sanctions imposed by the sanctions authority of the European Union or the United Nations and to the best of its knowledge neither is any person or entity that is an owner of Ovid (excluding owners of a non-controlling interest in publicly-traded securities) or otherwise has control over Ovid.

Ovid will use reasonable efforts to inform the National Library without delay if it becomes aware of any change in the sanctions status of itself or if it becomes aware of such sanctions with regards to a person or entity that is an owner of Ovid (excluding owners of a non-controlling interest in publicly-traded securities) or otherwise has control over Ovid. If there is a change in the aforementioned sanctions status the Subscriber has the right to terminate this Agreement with immediate effect. If the termination is due to change in Ovid's sanctions status, the Subscriber has also the right to receive a pro-rated refund of any Fees paid.

19.Intentionally Omitted.

20.CONFIDENTIALITY. Subscriber acknowledges that the Products and Software are the proprietary property of Ovid, its affiliates and the Information Providers, and that the processes and methodology used in producing the Products and Software are valuable trade secrets. Subscriber shall protect the confidentiality thereof with at least the same level of efforts that it employs to protect the confidentiality of its own proprietary and confidential information of like importance and in any event, by reasonable means.

Subscriber shall not disclose the terms of this Agreement, except as required by law or with Ovid's consent. This provision shall survive the expiration or earlier termination of this Agreement.







Schedule E: Open Access Publishing

The Subscribers (i.e., FinELIB Consortium members) will be granted collectively (i.e., across all members) the following number of article publication charge (APC) allowances in 2023 and 2024 for publication of Eligible Articles (as defined below) in LWW's hybrid and gold Open Access journals included in the LWW Total Access Collection (the "Included Journals", a current list of which is set forth in Schedule C) as follows:

- In 2023, 105 open access APC allowances for Eligible Articles accepted in such year for publication in one of the Included Journals.
- In 2024 109 open access APC allowances for Eligible Articles accepted in such year for publication in one of the Included Journals.

The open access APC allowances must be used in the calendar year of the subscription. If in 2023 the total number of APC allowances is exhausted, up to 10% (up to 11) of the following year's APC allowances may be used in 2023. In November 2023, if the Subscriber requests via the National Library, Ovid and the National Library acting on behalf of the Subscriber will evaluate the use of the APC allowances, and the National Library will advise Ovid in writing if it wishes to bring forward 2024 APC allowances into the 2023 contract period. - Reviews

For the avoidance of doubt, Articles that were accepted in 2022, regardless of when they are published, are not Eligible.

The below article types are not Eligible Articles:

- Editorials
- Correspondence
- Abstracts
- Errata

Each Subscriber via National Library shall provide to Ovid the parameters for identification of Affiliated Authors and timely updates of any changes in those parameters as soon as reasonably practicable, in order to enable Ovid or its affiliates to provide the technical means for the identification of Affiliated Authors.

Ovid will require its affiliate to disclose the availability of this program to Corresponding Authors within its article submission process and/or on its website. This disclosure will inform Eligible Authors that they may not need to pay Article Processing Charges ("APC") for Open Access Articles.

Process for identification of Affiliated Authors and open access publishing

Each Subscriber and/or the National Library also shall disclose this program to their Authorized Users, including informing them that: (a) in order to have their APC funded by this program they must (i) identify themselves as the Corresponding Author; (ii) disclose the institutional affiliation; and (iii) select open access, and (b) funding is subject to the institution's approval.

When submitting an article, Affiliated Authors will be identified through at least one of the following parameters: their Institutional affiliation or their e-mail domain, in each case, as provided by the Corresponding Author in the publisher's article submission system. The Subscriber will provide Ovid with a list of the email domains in its use as well as timely updates of any changes to them as soon as reasonably practicable.

In case Ovid or its affiliate, as applicable does not receive either a confirmation or a denial through the aforementioned online system within 3 business days after Ovid or its affiliate as applicable has notified the applicable Subscriber, Ovid or its affiliate as applicable will send a reminder, which shall inform Subscriber that Ovid or its affiliate will deem the author to be an Affiliated Author and continue the publication if the Subscriber does not respond within 4 days of the date of such reminder. The Subscriber may, if the Subscriber cannot verify that the author is an Affiliated Author for material reasons, request a reasonable extension of the grace period, but not more than 5 business days from the date of the initial notification of eligibility. If the Subscriber does not deny that the Corresponding Author is an Affiliated Author by the end of the 4-day period (or, if a grace period is extended, by the end of the grace period), the publisher may deem the Corresponding Author to be an Affiliated Author.

Once the Corresponding Author's eligibility has been validated or the Corresponding Author is deemed to be an Affiliated Author in accordance with the foregoing, if any APC Allowances remain available for the applicable period, one (1) APC Allowance will be considered used.

Eligible Articles shall be published under a Creative Commons license provided the Corresponding author completes the Publisher's License to Publish agreement. The license types currently offered by each Included Journal are listed in Attachment 1 to this Schedule E but are subject to change in each such journals' discretion.

If more than ten percent (10%) of the Included journals currently offer a CC BY license as specified in Attachment 1 to this Schedule E cease doing so, Ovid will use reasonable efforts to promptly inform the National Library of Finland.

If a Corresponding Author chooses CC BY-NC-ND for an article in an Included Journal that also offers CC BY, Ovid will, upon request of the Corresponding Author, permit the Corresponding Author to change the license to CC-BY (which may be subject to the Corresponding Author's signing a new license agreement and/or amendment)

provided such request is received no more than 90 days after the article publication date. The conversion of the license for which an APC allowance was used hereunder is not considered use of a second APC allowance from the totals set out above.

Authors retain copyright to their articles if they choose to publish under a Creative Commons License and sign the publisher's License to Publish agreement.

If the Subscriber timely denies the request for an APC allowance, or none remain available for the applicable period, for an Article through this Agreement, the publisher or its affiliate may offer such author the opportunity to pay the applicable APC or to publish under subscription terms.

Corresponding Author(s) that have not identified themselves as affiliated to a Subscriber or have not selected open access prior to publication shall have a 365-day window after publication of the article to so identify such affiliation and convert to Open Access under this Agreement (which shall be subject to execution of appropriate Open Access License Agreements within such period). The conversion may also be done before publication of the article. Once the Corresponding Author's eligibility has been validated by Subscriber or the Corresponding Author has been deemed an Affiliated Author in accordance herewith, one (1) APC Allowance will be considered used, if any are remaining for the applicable period.

Eligible Authors who have erroneously paid their own APC for an article accepted for publication in an Included Journal during the Term will be entitled to request a refund of the relevant APC. Such request must be received by Ovid within 365 days of publication. A refund will only be provided if any APC Allowances are available for the applicable period, and if a refund is provided, one APC Allowance will be considered used.

If the number of APC Allowances has been depleted at the time the Ovid will offer the author the option of self-funding the APC or to publish the article via the traditional route as a subscription article (not open access).

The final published article will be made openly available at the time of online publication.

The parties acknowledge the importance of a fluent workflow. Ovid and the National Library will review the workflow as set forth above on a regular basis during the duration of the Agreement.

 - Corresponding Author's affiliation (as provided by the author)
 - Journal Title
 - Journal online ISSN
 - Article title
 - Article type (if applicable)
 - DOI (if available)
 - Acceptance date
 - Open access election date (if available) i.e., the date the Corresponding Author elects open access and submits a signed Open Access license agreement
 - Creative Commons License type (if available)
 - APC list price

Ovid and the National Library acting on behalf of the Subscriber will jointly review the volume of all submitted articles and APC allowances within 30 days from the end of each calendar quarter during the Term.
