**Wolters Kluwer Health (Medical Research) Ltd.  
Online License Agreement**

This Agreement, dated this 31st day of December, 2017, between Wolters Kluwer Health (Medical Research) Limited a United Kingdom company having offices at 41<sup>st</sup> Floor, 25 Canada Square, London E14 5LQ, UK (hereinafter referred to as "Ovid") and The National Library of Finland, Unioninkatu 36,(P.O.Box 15), FIN-00014 UNIVERSITY OF HELSINKI, Helsinki, Finland ("the National Library") and other members of the FinELib Consortium, the other members of the FinELib Consortium represented by the National Library via a power of attorney (the National Library and other members each hereinafter referred to as "**Subscriber**" - as such are listed at Schedule D; collectively with Ovid, referred to as the "**Parties**") provides for use by Subscriber of the Products, as defined below, through Ovid's remote database access service for a fixed fee, subject to the terms and conditions set forth in this agreement (the "**Agreement**").

**1. DEFINITIONS.**

**1.1. "Products"** made subject to this Agreement consist of: (i) the "**Database(s)**," "**Journals**" and/or "**Books**" ordered by the Subscriber pursuant to Schedule(s) B and/or C, attached hereto; (ii) the "**Software**," ordered by the Subscriber pursuant to Schedule B, consisting of the search and retrieval application software and any modifications, enhancements, updates, upgrades or new releases produced by Ovid during the term of the Agreement; (iii) the "**Documentation**" consisting of any instructional materials produced and owned by Ovid relating to the Products as provided in hardcopy or electronic form during the term of the Agreement; (iv) computer capacity to support the number of concurrent users or site license, if applicable authorized by Subscriber pursuant to Schedule(s) B and/or C; and (v) subscriber support services, via telephone, facsimile transmission or Internet E-mail. For the avoidance of doubt, this Agreement applies only to Products listed on a Schedule C to this Agreement.

**1.2. "Authorized Site(s)"** means a Subscriber site composed of (i) single or multiple institutions, (ii) single or multiple geographic locations or (iii) a combination of the aforementioned for which Subscriber requests designation by Ovid as sites authorized to access the Products. A list of Authorized Site(s) for purposes of this Agreement is set forth in Schedule D, as such may be amended from time to time. In the event that Subscriber acquires or merges with another related or affiliated entity during the term of this Agreement, such acquired or merged entity may be deemed a separate additional site subject to additional access fees and subscription fees, at Ovid's discretion.

**1.3 "Authorized Users"** mean: (i) Subscriber; (ii) employees of Subscriber, if Subscriber is a corporation or other organization; provided however, that employees of an entity which is acquired by or merged with the Subscriber during the term of this Agreement will not be deemed Authorized Users for purposes of this Agreement without Ovid's consent; (iii) current members of the faculty, staff, employees, affiliated researchers, docents and contractors of the Subscriber (whether on a permanent, temporary, contract or visiting basis), individuals who are studying at a Subscriber institution, walk-in users, at a Subscriber facility if Subscriber is an academic institution, (iv) patrons of Subscriber, if Subscriber is a public library offering access to the Products; (v) employees, staff and researchers of Subscriber, if Subscriber is a research institution, walk-in-users at a Subscriber facility if the Subscriber's library is open to the public. Authorized Users may be persons affiliated with remote site or campuses, but not persons at remote sites or campuses with separate administrations. The applicable user model (e.g., site license, concurrent user, etc.) will be set forth on Schedules B and/or C. For purposes of this Agreement, any institutions, associations or organizations related or affiliated with Subscriber will not be deemed "Authorized Users" without Ovid's express consent.

**1.4 "Permitted Use"** means use of the Product(s) by Authorized Users only for the purpose of education, teaching, user training, distance learning, private study, retrieving information and/or research (Educational purposes).

This Agreement shall be deemed to complement and extend the rights of the Subscriber and Authorized Users under the Finnish Copyright law and nothing in this Agreement shall constitute a waiver of any statutory rights held by the Subscriber or Authorized Users from time to time under the Finnish Copyright law or any amending legislation.

Authorized Users may

- (i) view and display (also to other Authorized users) the content and data contained therein on computer or projection screens
- (ii) make limited copies of data obtained from searches in print (including photocopies) or electronic format for educational purposes, (iii) provide limited copies of data obtained from the searches in print or electronic format to other Authorized Users for educational purposes but limited solely to such educational purposes from an Authorized User to an Authorized User;
- (iv) electronically save data obtained from searches;
- (v) Authorized Users may distribute copies of parts of the Products in an incidental manner in print or electronic form to third party colleagues for the purposes of non-commercial scholarly communication or to be used for the basis of discussion groups only;
- (vi) Authorized users may display, save electronically, print and distribute to Authorized Users only limited parts of the Product including trademarks, logos and screenshots for the purpose of promotion or for training Authorized Users. Such limited parts may also be displayed on public websites operated by Licensee for the purpose of promotion or for training Authorized Users.
- (viii) Reading impaired Authorized Users may use Braille displays, voice synthesizers and other such devices to enable use of the Products.
- (ix) the print out of the Products may be used for Inter-Library Loan whereby articles can be delivered via printing or faxing or through the use of Ariel or a similar system to fulfill Inter-Library Loan requests from an academic, research or other non-commercial library.
- (x) Subscriber is authorized to incorporate parts of the Products in electronic Course or Study Packs for the use of Authorized Users in the course of instruction by using a link to the required material. Course packs in non-electronic non-print perceptible form, such as audio or Braille, may also be offered to Authorized Users who, in the reasonable opinion of the Subscriber, are reading impaired.
- (xi) For LWW content only, use the Products to perform and engage in data mining activities for Educational Purposes. Data mining is a machine process by which information may be derived by identifying patterns and trends within natural language through text categorization, statistical pattern recognition, concept or sentiment extraction, and the association of natural language with indexing terms.

Authorized Users who are library staff may

(xii) Produce translations of user guides and other promotional materials available at Ovid website (public or secure) or otherwise received from Ovid, electronically save/deposit such translations on any electronic network including networks open to the public, display and distribute such translations via any said electronic network for the purpose of promotion or for training Licensee's Authorized Users and for the use of other Licensees for the same purpose. Translations shall include appropriate acknowledgement of the source and copyright owner.

(xiii) Produce audio visual works that include parts of the Products (including trademarks, logos and screenshots), electronically save/deposit such works on any electronic network including networks open to the public, distribute and publicly perform such works via any said electronic network for the purpose of promotion or for training Authorized Users and for the use of other Licensees for the same purpose. Audio visual works shall include appropriate acknowledgement of the source and copyright owner.

In the event that any content included in the Products has been issued under a Creative Commons license, Ovid shall not place use restrictions on that content beyond those found in the applicable Creative Commons license.

The Permitted Use expressly precludes (i) copying, duplication, redistribution, retransmission, publication, transfer or commercial or other exploitation of the Product(s), in whole or in part, where such acts are contrary to the Permitted Use; (ii) preparation of derivative works or incorporation of the Products, in whole or in part, in any other work or system; (iii) reverse engineering, decompiling or modification of the Products, in whole or in part; and (iv) uploading, downloading, copying or redistributing the content in their entirety or lengthy sequence.

Commercial means use for the purposes of monetary reward (whether by or for the Subscriber or an Authorized User) by means of the sale, resale, license, loan, transfer, distribution, hire or other form of exploitation of the Products. For the avoidance of doubt, neither

- recovery of direct costs or costs required by law by the Subscriber from Authorized Users or from the receiving library in the case of Inter Library Loan,
- nor use by the Subscriber or by an Authorized User of the Products in the course of research funded by a commercial organization
- nor use by the Subscriber or by an Authorized User in not for profit fee-based educational programs, is deemed to constitute commercial exploitation.

## **2. USE OF THE PRODUCTS.**

- 2.1.** Ovid hereby grants to Subscriber the non-transferable, nonexclusive limited right to gain computerized access using the Software to the Product(s), subject to the terms and conditions of this Agreement. Authorized Users will use the Product(s) only in accordance with the Permitted Use.
- 2.2.** If requested by Subscriber, Ovid will issue Subscriber one or more identification password(s), such number to be determined at Ovid's discretion, to gain access to the Products during Ovid's scheduled hours of service. Where applicable, Subscriber agrees that the identification password(s) is valid only in the country in which it is issued and may be restricted from accessing certain data on the Products. Subscriber may elect to use proxy servers to allow its Authorized Users to access the Products remotely. Subscriber and its Authorized Users will access the Products via IP validation only. Except as provided in Section 5.3 of this Agreement, Subscriber is responsible for all charges against Subscriber's identification password(s). Ovid reserves the right, at its sole discretion, to alter or change Subscriber's identification password(s) as circumstances may warrant.
- 2.3.** Ovid will provide administration accounts to the National Library and the Subscriber that allows the National Library and Subscriber to log in, view and analyse usage COUNTER compliant data of searches and in the case of journals downloads monthly per title per organization.
- 2.4.** To improve the use of the subscribed products Ovid will provide Subscriber with online trainings.
- 2.5.** Ovid will use its best endeavors to make the Products available to Authorized Users 24 hours a day 7 days a week, save for routine maintenance and to restore access as soon as possible in the event of any interruption or suspension of the service. If the online service is interrupted for a period of two weeks or more due to a failure by Ovid, Ovid shall refund that part of the fee in proportion to the time that the Products has not been available as a result of service interruptions.
- 2.6.** Ovid will make every commercially reasonable effort to ensure that the Products are OpenURL compliant for the term of the agreement.
- 2.7.** Ovid will use its reasonable endeavors to meet the W3C standards ([www.w3.org/WAI/Resources/#in](http://www.w3.org/WAI/Resources/#in)) in order to ensure that the Products are accessible to all Authorized Users.
- 2.8.** Ovid will use reasonable endeavors to provide an OAI-PMH metadata harvesting interface or otherwise provide for harvesting of bibliographic records into an integrated search solution for the Subscriber's use. Ovid will also use reasonable endeavors to make the metadata available through the Primo Central Index metadata aggregation service and other such services..

2.9. Ovid will use reasonable endeavors to adhere to the specifications of the standards <http://www.uksg.org/kbart/s5/guidelines>).

2.10. Ovid will use reasonable endeavors to adhere to the specifications of the Transfer Code of Conduct (<http://www.uksg.org/transfer>).

2.11. Perpetual Access rights. For journals subscribed to during the term of this Agreement, subject to the provisions of the immediately following paragraph of this Section 2.11, Subscriber shall be entitled to the perpetual access rights related to those journals at the time of contract. The current perpetual access policy can be found at in Schedule C. In the event of a conflict between this Section 2.11 and such archive policy, the terms of this Section 2.11 will govern.

The archival rights per journal as currently exist are as set out in Schedule C. Such rights for journals not wholly owned by Ovid or an affiliate of Ovid are subject to change without notification to Subscriber although every reasonable effort will be made to notify Subscriber of such changes in line with Section 16 below. Archival rights to journals wholly owned by Ovid or an affiliate of Ovid are guaranteed for the period of time for which they remain wholly owned by Ovid or any such affiliate of Ovid. If a journal wholly owned by Ovid or an affiliate of Ovid is transferred to a new owner Subscriber will continue to have perpetual access archival rights to issues published prior to the date of transfer. Perpetual access rights will be provided to Subscriber by Ovid via Portico or such other electronic method as Ovid shall determine in its sole discretion, subject to Subscriber's payment of reasonable media, fulfillment, delivery, and/or maintenance fees.

### 3. PROPRIETARY RIGHTS AND USE RESTRICTIONS FOR THE PRODUCT(S).

3.1. The Software is produced and owned by Ovid; the content is licensed to Ovid under separate agreements between Ovid and certain information providers ("Information Providers") and are proprietary to Information Providers. No provision of this Agreement conveys any ownership interest in or to the Products, in whole or in part. Title, as well as applicable copyrights, patents, trademarks, trade secrets or other intellectual property rights in and to the materials in the Products are, and remain the property of Ovid, Information Providers or individual copyright claimants, as applicable.

3.2. No rights to use the Product(s) are conveyed to the Authorized Users except as permitted by this Agreement and, if applicable, pursuant to the user guidelines produced by Information Providers, as made available by Ovid, from time to time, in electronic or print form.

3.3. Information Providers and / or Ovid may modify or assign additional terms and conditions, as made available to Subscriber by Ovid, from time to time, which affect the Authorized Users' use of the Product(s), including without limitation, changes in subscription rates, use restrictions or guidelines. Ovid will communicate any such changes to Subscriber in writing and such changes will become effective upon Subscribers acceptance at the time of their next renewal. Subscriber hereby grants to Ovid and/or Information Providers the right to enforce or assert on their own behalf the provisions of this Agreement to the extent they pertain to the content contained in the Product(s).

4. Intentionally deleted.

5. **SUBSCRIBER'S OBLIGATIONS.** Subscriber agrees to the following:

5.1. to be responsible for installation, costs and maintenance of a communications link and equipment;

5.2. to be responsible for communication costs incurred by any Authorized User connecting to the Product with a valid password;

- 5.3. to be responsible for the confidentiality and security of the identification password(s) issued to Subscriber by Ovid. Subscriber will not be responsible for charges against any identification password(s) that are lost or stolen; provided Ovid has received prompt notice to such effect;
- 5.4. if reasonably requested by Ovid to designate in writing a staff member to be "System Administrator" (project manager) for the purpose of resolving implementation questions, such person to be available to Ovid on a routine and expedited basis when necessary;
- 5.5. Use reasonable endeavors to ensure that all Authorized Users are appropriately notified of the importance of respecting the intellectual property rights in the Products and of the sanctions which Subscriber imposes for failing to do so;
- 5.6. Use reasonable endeavors to notify Authorized Users of the terms and conditions of this Agreement and take steps to protect the Products from unauthorized use or other breach of this Agreement;
- 5.7. Immediately upon becoming aware of any unauthorized use or other breach, inform OVID and take all reasonable and appropriate steps, including disciplinary action, both to ensure that such activity ceases and to prevent any recurrence;
- 5.8. Use reasonable endeavors to ensure that only Authorized Users are permitted access to the Products;
- 5.9. Nothing in this Agreement shall make the Subscriber liable for breach of the terms of the Agreement by any Authorized User provided that the Subscriber did not cause, knowingly assist or condone the continuation of such breach to continue after becoming aware of an actual breach having occurred.

## **6. LIMITED WARRANTIES AND LIMITED LIABILITIES.**

- 6.1. Ovid represents and warrants that it has the complete right and authority to enter into this Agreement and to deliver the Products "AS IS".
- 6.2. Ovid will use its best efforts to provide the Product(s) in accordance with the Documentation existing at the date of initial access.
- 6.3. As a consequence of factors affecting the transmission of the Products which are beyond Ovid's control, Ovid will not guarantee performance of the Products through the Internet or other transmission modes. In the event that Subscriber requires greater surety of access, Ovid may arrange for Subscriber to have dedicated circuit access to the Products through a leading telecommunications carrier for an additional charge to be determined.
- 6.4. **OVID AND INFORMATION PROVIDERS EXPRESSLY DISCLAIM AND EXCLUDE ALL WARRANTIES (INCLUDING WITHOUT LIMITATION, MERCHANTABILITY AND FITNESS FOR A PARTICULAR PURPOSE, AND REPRESENTATIONS, WHETHER EXPRESS OR IMPLIED, IN RELATION TO THE PRODUCTS, THE CONTENT CONTAINED THEREIN AND THEIR PROVISION UNDER THIS AGREEMENT. ALTHOUGH DUE CARE IS USED IN PREPARING THE PRODUCTS, OVID AND INFORMATION PROVIDERS MAKE NO WARRANTIES THAT ACCESS TO THE PRODUCT(S) WILL BE UNINTERRUPTED OR THAT THE PRODUCTS WILL MEET SUBSCRIBER'S REQUIREMENTS, OR THAT THE CONTENT IS ACCURATE OR COMPLETE OR THAT THE RESULTS OBTAINED BY ANY AUTHORIZED USERS WILL BE ERROR FREE. NO OVID EMPLOYEE OR AGENT IS AUTHORIZED TO MAKE ANY STATEMENT THAT ADDS TO OR AMENDS THE WARRANTIES OR LIMITATIONS CONTAINED IN THIS AGREEMENT.**
- 6.5. **EXCEPT AS PROVIDED UNDER THE INDEMNITY OF SECTION 7.0 OF THIS AGREEMENT, NEITHER OVID NOR INFORMATION PROVIDERS WILL BE LIABLE TO SUBSCRIBER, OR AUTHORIZED USERS FOR LOSS OF PROFITS, LOSS OF USE OR FOR ANY INDIRECT, SPECIAL OR CONSEQUENTIAL DAMAGES WHETHER BASED UPON A**

**CLAIM OR ACTION OF CONTRACT, WARRANTY, NEGLIGENCE, STRICT LIABILITY OR OTHER TORT, EVEN IF THEY ARE AWARE OF THE POSSIBILITY THEREOF. SUBSCRIBER AGREES THAT, EXCEPT AS PROVIDED UNDER SECTION 7.0 OF THIS AGREEMENT, THE ENTIRE LIABILITY OF OVID AND INFORMATION PROVIDERS, AND THE EXCLUSIVE REMEDY OF THE SUBSCRIBER OR ANY THIRD PARTY, WILL IN NO EVENT EXCEED AN AMOUNT EQUAL TO THE FEE PAID FOR THE USE OF THE PRODUCTS. THE LIMITATIONS ON LIABILITY SPECIFIED HEREIN SHALL NOT APPLY IN A CASE WHERE OVID AND /OR INFORMATION PROVIDERS HAVE CAUSED THE DAMAGE DELIBERATELY OR THROUGH GROSS NEGLIGENCE.**

**6.6. FOR THE AVOIDANCE OF DOUBT EACH SUBSCRIBER (MEMBER OF THE FINELIB CONSORTIUM) WILL ONLY BE LIABLE FOR ITS OWN ACTIONS AND/OR DEFAULTS.**

6.7. Neither Ovid nor its employees and agents will be liable for assistance provided to Authorized Users in performing research using the Products and any such assistance received from Ovid employees or agents will be solely at Authorized Users' risk.

6.8. Authorized Users, including physicians, health care workers and other professional persons using the Products MAY NOT rely on the information contained in the Products. Alternatively, they must rely on their clinical discretion, judgment and expertise in diagnosis and treatment.

6.9. Any cause of action brought by any party to this agreement concerning the Products must be commenced within one (1) year after such cause of action has accrued.

## **7. INDEMNIFICATION.**

7.1. OVID warrants and represents that, it is the owner of the copyright in the Products or that it is duly licensed to use the copyrighted material contained in the Products and that, the Products used as contemplated in this Agreement does not infringe any copyright or other proprietary or intellectual property rights of any natural or legal person.

7.2. OVID shall indemnify and hold the Subscriber harmless from and against any loss, damage, cost, liability or expense (including reasonable legal and professional fees) arising out of any legal action taken against the Subscriber claiming actual or alleged infringement of such rights. This indemnity shall survive the termination of this Agreement for any reason. This indemnity shall not apply if the Subscriber has amended the Products in any way not permitted by this Agreement, and such amendment has caused the loss, damage, cost liability or expense.

8. **PAYMENT.** The price for use of the Ovid Fixed-Fee Online Service is set forth in Schedule(s) B. Payment will be due upon the execution of this Agreement, pursuant to Subscriber's purchase order attached hereto. All invoices are due sixty (60) days after the receipt of the invoice. In the event that Subscriber fails to make prompt payment, Ovid reserves the right to deny access to the Products until such time as Subscriber's account is made current. Subscriber will be responsible for the payment of all local taxes, or other related fees incurred in connection with this Agreement. If Subscriber shall fail to make any required payment within ten (10) days from the date the same become due and payable, such unpaid amounts shall bear interest from the due date thereof to the date of payment at the rate of eighteen percent (18%) per annum or the highest rate permitted by applicable law, whichever is less.

9. **TERM.** The term of this Agreement will be five (5) years from the date of initial access to the products, i.e. from December 31<sup>st</sup>, 2017 until December 31<sup>st</sup> 2022.

10. **TERMINATION.** If Ovid or any one of the Subscribers is in breach of the terms and conditions of this Agreement, the breaching party will have ten (10) business days in which to cure the breach. If the breaching party has not cured the breach, the non-breaching party may terminate this Agreement, in addition to pursuing all other legal remedies. The provisions of this Agreement which protect the proprietary rights of Ovid and

Information Providers as well as clauses 2.11 and 7 will continue in force after termination. Additionally, clauses 1.3 and 1.4 will continue in force after termination, but only to the extent necessary to allow Authorized Users perpetual access granted to such Authorized Users under this Agreement, subject to the limits of such perpetual access set forth in this Agreement. Any termination, whether or not for breach, will not affect any right, obligation or liability of a party arising prior to termination of the Agreement. If any of Subscribers is in breach and such breach is not cured within ten (10) business days Ovid has the right to immediately terminate this Agreement with respect to such breaching Subscriber and pursue all legal action necessary against that Subscriber without affecting the rights and obligations of the remaining Subscribers under this Agreement but subject to a renegotiation in pricing if applicable in accordance with clause 17. Subscribers shall provide to Ovid all reasonable cooperation and assistance that Ovid may request in the enforcement of Ovid's rights against an infringing member-Subscriber.

- 11. ENTIRE AGREEMENT; AMENDMENT.** This Agreement (including all appendices), will constitute the entire agreement of the Parties. It is expressly agreed that any terms of a purchase order or similar instrument issued by Subscriber with respect to this Agreement will not affect the terms and conditions of this Agreement. This Agreement may not be modified or amended except by written consent of the Parties or in accordance with the provisions set forth in Subsection 3.3. of this Agreement.
- 12. NOTICES.** All notices, consents or other communications referred to herein will be in writing and will be conveyed to the other party by First Class Mail or electronically at the appropriate addresses indicated in Schedule A by the Parties. Service of such notice, consent or other communication hereunder will be effective on the fifth day after the day of mailing or the same day as the day of transmission.
- 13. FORCE MAJEURE.** Neither party will be liable for any delay, failure in performance or interruption of service due to any unforeseen circumstances or circumstances beyond its control, including, without limitation, war, strikes, civil disturbances and Acts of God.
- 14. SEVERABILITY.** If a term or condition of this Agreement is found by a court or administrative agency to be unenforceable, the remaining terms and conditions will remain in full force and effect.
- 15. GOVERNING LAW.** This Agreement will be governed by the laws of the State of New York, without giving effect to the principles of conflict of law thereof. Any dispute, controversy or claim arising between the parties of this agreement under or in connection with this agreement shall be settled in arbitration in accordance with the Rules of Arbitration Committee of the Finnish Central Chamber of Commerce pursuant to the regulations in force. The arbitration shall take place in Helsinki, Finland, in the English language
- 16. PRODUCT LOST OR JOURNALS TAKEN OVER BY OTHER PUBLISHERS.** In the event that Ovid loses the right to distribute any Product or if any of Ovid's Journals are taken over by another publisher during the term of this Agreement, Subscriber will either still have the right to access the Product through the remainder of the term of their subscription for no extra charge or will be entitled to a pro-rated refund. Ovid shall use reasonable commercial efforts to notify the National Library on behalf of the Subscriber of any such change within four (4) weeks of such change being agreed or four (4) months prior such change taking place.
- 17. OPT-OUT-CLAUSE.** At any time before the completion of any year of the term of this Agreement, upon at least three (3) months written notice to Ovid before the end of each subscription year, Subscriber may terminate the participation in this Agreement without incurring in any penalty of costs (the "Opt-Out Right") ; provided, however, that:
  - A. If, after Subscriber exercises the Opt-Out Right, Subscriber desires to subscribe to LWW Total Access again during the remainder of the term of this Agreement or any portion of the term of this Agreement, the applicable Subscriber shall not be automatically eligible for the discounted pricing or any other rights offered by Ovid on the date of this Agreement for the 2018-2022 term, and Ovid shall provide an offer for the pricing and any other rights to be offered to such Subscriber.
  - B. After Subscriber exercises the Opt-Out Right, such Subscriber shall be deleted from Schedule D and Subscriber's price for any year subsequent to the exercise of the Opt-Out Right for such Subscriber shall

be deleted from Schedule B.

- C. Subscriber shall maintain its rights to the Permitted Use of the Products paid for prior to the date of any such termination described above, as provided for in Section 2.11.

For avoidance of doubt, each Subscriber can only exercise the Opt-Out Right for itself and not for any other Subscriber.

IN WITNESS WHEREOF, the Parties have caused this Agreement to be executed and hereby represent and warrant that their respective signatory below has been and is, on the date of this Agreement, duly authorized by all necessary corporate action to execute this Agreement.


